**2014 RESOLUTION APPOINTMENT**

**ACTING DIRECTOR OF POLICE**

**WHEREAS**, it is necessary to appoint an Acting Director of Police; and

**WHEREAS**, Samuel DeMaio has indicated his willingness to perform the duties of the position; and

**WHEREAS**, the Finance Director has indicated funding is available for this appointment.

**NOW, THEREFORE, BE IT RESOLVED**, by the Mayor and Council of the Township of Bloomfield, County of Essex, State of New Jersey, that Samuel DeMaio is hereby appointed to the position of Acting Director of the Police Department effective September 16, 2014; and

**BE IT FURTHER RESOLVED**, that the Acting Director shall be paid in accordance with the salary ordinance in effect for the position of Director of Police and he shall have the same duties, responsibilities and powers as the Director in the Director's absence; and

**BE IT FURTHER RESOLVED**, that the Acting Director of the Police Department shall receive 25 vacation days, 15 sick days, and 5 personal days per year and all other benefits provided for that position; and

**BE IT FURTHER RESOLVED**, that the Acting Director shall be required to perform a minimum of 40 hours of work per week on average and shall be considered a fulltime employee, receiving all of the benefits thereof; and

**BE IT FURTHER RESOLVED**, that this appointment shall conclude August 21, 2015, unless the Mayor and Council decided to extend the appointment.


