**2017 RESOLUTION AWARD OF CONTRACT**

**AUTHORIZING THE 2017 AWARD OF A NON-FAIR AND OPEN CONTRACT FOR TOWNSHIP SUPPORT SERVICES WITH REACH SPORTS MARKETING GROUP CORPORATION**

**WHEREAS**, the Township of Bloomfield needs the services of support of their Reach Sports Marketing Group Corporation system throughout the township; and

**WHEREAS**, the Township desires to make this appointment under the provisions N.J.S.A. 19:44A-20.5, as a non-fair and open contract; and

**WHEREAS**, the Township IT Director has determined that the value of these services will not exceed \$17,500; and

**WHEREAS**, Reach Sports Marketing Group Corporation, has completed and submitted the attached Business Entity Disclosure Certification which certifies that he has not made any reportable contributions to a political or candidate committee in the Township of Bloomfield in the previous one year, and that the contract will prohibit Reach Sports Marketing Group Corporation from making any reportable contributions through the duration of this contract; and

**WHEREAS**, the Director of Finance has certified that funds are available to cover the cost of this service in account # 7-01-20-707-029 and not to exceed in the amount of \$1,500.00.

**NOW, THEREFORE, BE RESOLVED**, that the Mayor and Council of the Township of Bloomfield authorizes the Township IT Director to enter into a contract with Reach Sports Marketing Group Corporation as described herein; and

**BE IT FURTHER RESOLVED**, that no minimum payment is implied or guaranteed; and


**BE IT FURTHER RESOLVED**, that the above documents shall be available for public inspection at the office of the Township Clerk during regular business hours; and

**BE IT FURTHER RESOLVED**, that in accordance with Standardized Submission Requirements the Township reserves the right to cancel this contract upon thirty (30) days notice and the Professional shall only be paid for the work completed or on a pro-rated amount if the contracts calls for a monthly retainer; and

**BE IT FURTHER RESOLVED**, that a notice of this action shall be printed once in the official newspaper of the Township of Bloomfield.


