2017 RESOLUTION AWARD OF CONTRACT

AUTHORIZING THE 2017 AWARD OF A NON-FAIR AND OPEN CONTRACT FOR PROFESSIONAL SUPPORT OF POLICE CAD SYSTEM

WHEREAS, the Township of Bloomfield Police Department needs the services of professional support of their communication CAD system; and

WHEREAS, the Township desires to make this appointment under the provisions of N.J.S.A. 19:44A-20.5, as a non-fair and open contract; and

WHEREAS, the Township Police Director has determined that the value of these services will exceed \$17,500; and

WHEREAS, Lawsoft, Inc. has completed and submitted the attached Business Entity Disclosure Certification which certifies that he has not made any reportable contributions to a political or candidate committee in the Township of Bloomfield in the previous one year, and that the contract will prohibit Lawsoft, Inc. from making any reportable contributions through the duration of this contract; and

WHEREAS, the Director of Finance has certified that funds are available to cover the cost of this service in account #7-01-20-707-024 and not to exceed in the amount of \$30,000.00.

NOW, THEREFORE, BE RESOLVED, that the Mayor and Council of the Township of Bloomfield authorizes the Township Police Director to enter into a contract with Lawsoft, Inc. as described herein; and

BE IT FURTHER RESOLVED, that no minimum payment is implied or guaranteed;




