2017 RESOLUTION AWARD OF CONTRACT

AWARD OF CONTRACT - BLOOMFIELD AVENUE SEWER REPLACEMENT

WHEREAS, after the required legal advertising was published, sealed bids were received in the Council Chambers of the Municipal Building, Bloomfield, New Jersey on May 11, 2017 by the Purchasing Committee of the Township of Bloomfield in accordance with N.J.S.A. 40A:11-1 et seq., "Local Public Contracts Law" for the Bloomfield Avenue Sewer Replacement Program; and

WHEREAS, a total of three bids were received and referred to the Project Consultant,
Alaimo Group and the Township Engineer for review; and

WHEREAS, after review of the bids by the Township Engineer, the apparent low bidder was determined to be Stanziale Construction, LLC, P.O. Box 2597, Bloomfield, NJ 07003 for a total contract amount of \$135,913.00; and

WHEREAS, after review of the bids by the Township Engineer and the Township Attorney, the bid package submitted by Stanziale Construction was determined to be complete and responsive; and

WHEREAS, after favorable review of the qualifications of the low bidder by the project consultant, the Township Engineer recommends that the contract be awarded to Stanziale Construction, LLC, P.O. Box 2597, Bloomfield, NJ 07003 for a total contract amount of \$135,913.00; and

WHEREAS, the Director of Finance has indicated that funding is available in Capital Account C-04-55-704-987.
