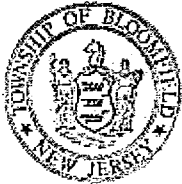

**2017 RESOLUTION AWARD OF CONTRACT**

**AUTHORIZING THE 2017 AWARD OF A NON-FAIR AND OPEN CONTRACT FOR GRAPHIC ARTIST WITH MACGRAPHICS**

WHEREAS, the Township of Bloomfield needs the services of a graphic artist for the Bloomfield Greenway Committee; and

WHEREAS, the Township desires to make this award under the provisions N.J.S.A. 19:44A-20.5, as a non-fair and open contract; and

WHEREAS, the Township Recreation Director has determined that the value of these services will not exceed \$14,500.00; and

WHEREAS, MacGraphics, 19 Budd Street, Morristown, NJ 07960 has submitted a Business Entity Disclosure Certification which certifies that the MacGraphics has not made any reportable contributions to a political or candidate committee in the Township of Bloomfield in the previous one year, and that the contract with MacGraphics from making any reportable contributions through the duration of this contract; and

WHEREAS, the Director of Finance has certified that funds are available to cover the cost of this service in account # C-04-55-720-975 and 6-01-40-367-028 not to exceed in the amount of \$14,500.00.

NOW, THEREFORE, BE RESOLVED, that the Mayor and Council of the Township of Bloomfield authorizes the Recreation Director to enter into a contract with of MacGraphics as described herein; and

BE IT FURTHER RESOLVED, that no minimum payment is implied or guaranteed;

and

APPROVED AS TO FORM AND PROCEDURE  
ON BASIS OF FACTS SET FORTH

DIRECTOR OF LAW-TOWNSHIP ATTORNEY

**BE IT FURTHER RESOLVED**, that the Business Disclosure Entity Certification, the Township Recreation Director's Determination of Value, the proposal of MacGraphics and the contract itself be placed on file with this resolution; and

**BE IT FURTHER RESOLVED**, that the above documents shall be available for public inspection at the office of the Township Clerk during regular business hours; and

**BE IT FURTHER RESOLVED**, that in accordance with Standardized Submission Requirements the Township reserves the right to cancel this contract upon thirty (30) days' notice and the Professional shall only be paid for the work completed or on a pro-rated amount if the contracts calls for a monthly retainer; and

**BE IT FURTHER RESOLVED**, that a notice of this action shall be printed once in the official newspaper of the Township of Bloomfield.


