AN ORDINANCE TO AMEND AND SUPPLEMENT CHAPTER 387 OF THE BLOOMFIELD TOWNSHIP CODE, PROVIDING PARKING FOR PHYSICALLY LIMITED PERSONS

BE IT ORDAINED by the Mayor and Council of the Township of Bloomfield, County of Essex, State of New Jersey, as follows:

Section 1. Chapter 387, entitled: "PARKING FOR HANDICAPPED", Section 387-4, "Enumeration of restricted parking areas", of the Code of the Township of Bloomfield is hereby amended by the addition of the following:


- (376) Hobson Street, north side, starting at a point 234 feet west of the westerly curb line of Broughton Avenue Street and running 20 feet west there from (95 Donald Street)
- (377) N. 17th Street, west side, starting at a point 103 feet south of the southerly curb line of Bloomfield Avenue and running 20 feet south there from (287 N. 17th Street)

Section 2. All ordinances inconsistent herewith are hereby repealed.

Section 3. This ordinance shall take effect upon final passage and publication in accordance with the law.


