

**AN ORDINANCE TO AMEND CHAPTER 99, "SPECIAL IMPROVEMENT DISTRICTS" ARTICLE I "Bloomfield Center," § 99-11 "Effective date," IN THE CODE OF THE TOWNSHIP OF BLOOMFIELD, COUNTY OF ESSEX, STATE OF NEW JERSEY**

**BE IT ORDAINED**, by the Mayor and Council of the Township of Bloomfield, County of Essex, State of New Jersey, as follows:

**Section 1.** Chapter 99 "SPECIAL IMPROVEMENT DISTRICTS", Article I, § 99-11, "Effective date", of the Code of the Township of Bloomfield, County of Essex, State of New Jersey, is hereby amended by the deletion of the following:

**§ 99-11 Effective date.**

The effective date of this ordinance shall be ten (10) days after its final passage by the Township Council and approval by the Mayor at the time and in the manner provided by law and shall remain in effect for a five year period until the fifth anniversary of the date of the final passage of the ordinance and shall automatically cease and be of no force and effect after that date unless specifically extended by the Governing Body by ordinance extending such term. Any such extension action must be taken by the governing body prior to the expiration of this ordinance.


**Section 2.** All ordinances inconsistent herewith are hereby repealed.

**Section 3.** This ordinance shall take effect ten (10) days after the first publication thereof, after final adoption.




