**AN ORDINANCE TO AMEND AND SUPPLEMENT CHAPTER 387 OF THE BLOOMFIELD TOWNSHIP CODE, PROVIDING PARKING FOR PHYSICALLY LIMITED PERSONS**

**BE IT ORDAINED** by the Mayor and Council of the Township of Bloomfield, County of Essex, State of New Jersey, as follows:

**Section 1.** Chapter 387, entitled: "PARKING FOR HANDICAPPED", Section 387-4,A "Enumeration of restricted parking areas", of the Code of the Township of Bloomfield is hereby amended by the addition of the following:

- (381) Beekmen Street, south side, starting at a point 82 feet west of the westerly curb line of North Spring Street and running 20 feet west there from (39 Beekman Street)
- (382) Broughton Avenue, east side, starting at a point 295 feet south of the southerly curb line of Pilch Street and running south there from ( Demarest school)
- (383) Salter Place, west side, starting at a point 251 feet north of the northerly curb line of Franklin Street and running 20 feet north there from. (11 Salter Place)

**Section 2.** All ordinances inconsistent herewith are hereby repealed.


**Section 3.** This ordinance shall take effect upon final passage and publication in accordance with the law.




