

**AN ORDINANCE TO AMEND AND SUPPLEMENT CHAPTER 387 OF THE BLOOMFIELD TOWNSHIP CODE, PROVIDING PARKING FOR PHYSICALLY LIMITED PERSONS**

**BE IT ORDAINED** by the Mayor and Council of the Township of Bloomfield,

County of Essex, State of New Jersey, as follows:

**Section 1.** Chapter 387, entitled: "PARKING FOR HANDICAPPED", Section 387-

4, "Enumeration of restricted parking areas", of the Code of the Township of Bloomfield is

hereby amended by the addition of the following:

- (371) Dewey Street, south side, starting at a point 120 feet west of the westerly curb line of Broughton Avenue and running 20 feet west there from (84 Dewey Street)
- (372) Roylton Place, south side, starting at a point 121 feet west of the westerly curb line of Ampere Pkwy and running 20 feet west there from (10 Roylton Place)
- (373) Walnut Terrace, south side, starting at a point 40 feet east of the easterly curb line of Walnut Street and running 20 feet east there from (119 Walnut Terrace)
- (374) Williamson Avenue, east side, starting at a point 378 feet west of the northerly curb line of Montgomery Street and running 20 feet north there from (31 Williamson Avenue)

**Section 2.** All ordinances inconsistent herewith are hereby repealed.

**Section 3.** This ordinance shall take effect upon final passage and publication in accordance with the law.
